

Westwood Income Opportunity Fund

Section 19(a) Notification of Sources of Distribution

On April 30, 2026, the Westwood Income Opportunity Fund (the “Fund”), an open-end management investment company paid a distribution on its Class A, Class C, Institutional Class and Ultra Class shares of \$0.0313, \$0.0227, \$0.0344 and \$0.0342 per share, respectively to shareholders of record at the close of business on April 28, 2026. No action is required on your part.

The final determination of the tax character of the distributions paid in 2026 will be reported to shareholders in early 2027 on Form 1099-DIV.
